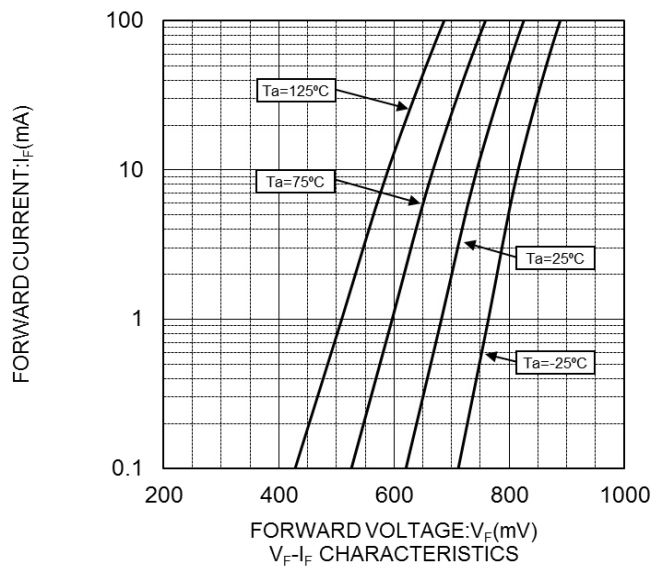
● Electrical Characteristic Curves



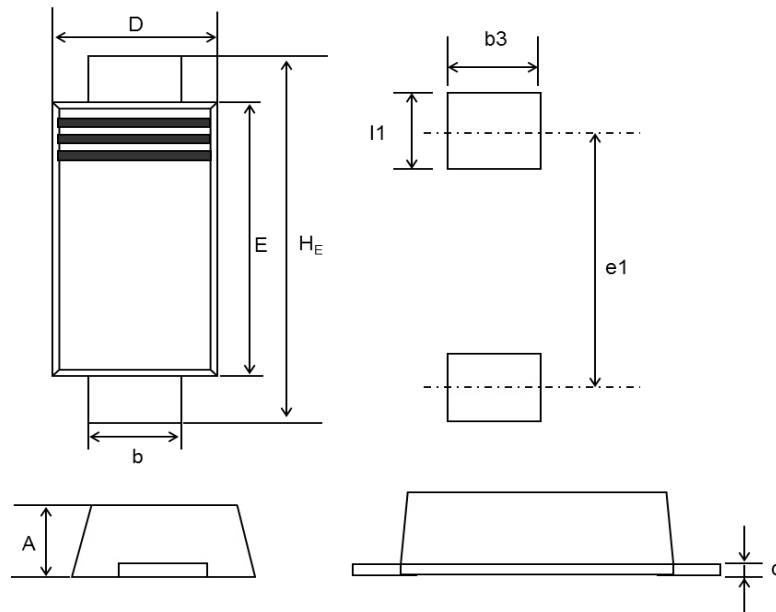

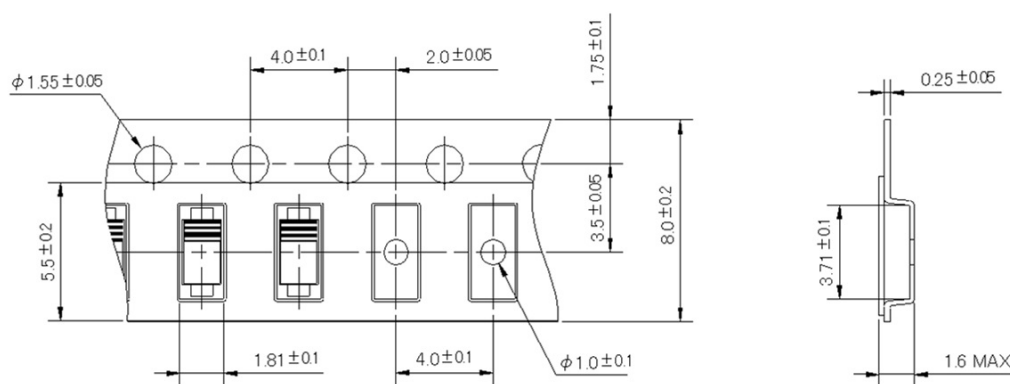
